The Internal Committee shall come into force with immediate effect and shall cease after a period of 3 years.

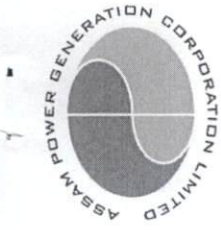
