They must have at least 01 (one) no. experience of manufacturing, supplying, installation, testing & commissioning of ACHE in Refinery / Petrochemical / Oil & gas processing units/Power Industry etc. during the last TEN (10) years. In this past experience, the bidder must be a single point vendor for executing the entire work which must also include supply, installation & commissioning of driver, fan etc. of the ACHE. In the above supplied ACHE as past experience, the Material of Construction should be Killed Carbon Steel [SA 516 Gr. 60] or higher for headers, SA 179 or higher for tubes, Tubes with Aluminum fins and having Plug Type Headers. This shall be complied by Bidder in a single Air-Cooled Heat Exchanger (ACHE) only. Bidders shall submit relevant credentials in support of the past experience along with their technical bid. Such credentials shall include but not limited to work order copy, work completion report, performance report, test report signed by client, documents stating material of construction details of the supplied items duly signed and verified by client etc.
