

- b) The participating bidder **shall superscribe the envelope** with the following information: -

 2. **Enquiry Quotation Number**
 3. **Due Date**
 4. **Name and address of the bidder**

Terms and Conditions:

- a. **L1 Bidder Selection:** The L1 bidder shall be selected based on the lowest total offered price of bidder (whose offered products are found technically acceptable) and which shall be inclusive of GST, P&F, Freight, Transit Insurance etc. The bidder shall fill up the price bid as given in the format below as Annexure-I.
- b. **Price:** The rates should be quoted for **FOR KLHEP, APGCL, Karbi Anglong** per unit. GST shall be quoted separately for each unit. The rates should be inclusive of all other charges.
- c. **Price Validity:** The prices quoted by the bidders shall be valid up to **30 (thirty) days** from the date of opening of the sealed quotations.
- d. **Work Completion Period:** The work completion period for the entire work of "Supply of 01 (one) no. Desktop PC at Karbi Langpi Hydro Electric Project, APGCL" shall be **30 (Thirty) days** from the date of issue of Work Order.

- g. **Payment Terms:** 100% payment of the total work order value shall be made after successful completion of the entire work of Supply of 01 (one) no. Desktop PC at Karbi Langpi Hydro Electric Project, APGCL and acceptance of the ordered items.
- h. **Liquidated Damage:** In case of delay in work completion beyond the work completion period, APGCL shall be entitled to: -
 - Recover an amount at the rate of 0.5% of the total value of Uncompleted Work per week or part thereof of delay, subjected to maximum of 10% (ten percent) of the Contract Price/Work Order value of Uncompleted Work as Liquidated Damage. However, the payment of liquidated damage shall not in any way relieve the Contractor from any of its obligation to complete the work or from any other obligation and liabilities of the Contractor under the Contract/as per work order.
 - Complete the balance work giving notice to the Contractor and to recover any extra expenditure incurred thereby for having to complete the work at a higher price, at the risk and responsibility of the Contractor.
 - Cancel the Work Order wholly or in part and to execute the work at the full risk and cost of the Contractor.

- i. The rates once quoted shall be firm without any variations until the successful completion of the entire work of supply.
- j. All other terms and conditions shall be as per the "General Conditions for Supply and Erection, 2014" of APGCL. The same may be obtained from APGCL website.


