SECTION 1: INVITATION FOR BIDS

(A) INTRODUCTION and OBJECTIVE:

(i) Introduction:

Assam Power Generation Corporation Ltd. (APGCL) is a state GENCO operating in the state of Assam and with the vision of availability of reliable and quality power at competitive rates and on a sustainable basis.

APGCL has various gas based thermal power plants as well as hydro power plants. The gas based thermal power plants Namrup Thermal Power Station/ Namrup Replacement Power Project located in the District of Dibrugarh, Assam has combined installation capacity of 139.4 MW.

(ii) Objective of the Tender:

The objective of this tender is to execute the supply of the required numbers of Thrust & Ball Bearing for Cooling Water Pump at Namrup Replacement Power Plant on emergent basis.

(B) Intent of Tender:

The intent of this tender document is to furnish the work scope for supply of the required numbers of Thrust & Ball Bearing of Cooling Water Pump at Namrup Replacement Power Project as well as provide technical and commercial requirements to be furnished and fulfilled by the bidders participating in the tender.

(C) Eligibility of Bidder:

1. The bidder must have an average annual turnover of at least Rs.1,80,000/- (Rupees One lakh Eighty thousand) only during the last 03(three) financial year, FY 2021-22, 2022-23 and 2023-24
 - In this regard, a certified copy from the Chartered accountant should be submitted by the bidder along with his bid.
2. A copy of the valid GST registration certificate shall be furnished by the bidder.
3. Copy of income tax return (ITR) of the last 03 (three) Financial Year (i.e., FY 2021-22, 2022-23 and 2023-24) shall be furnished by the bidder.
4. A copy of the Pan card shall be furnished by the bidder.
5. The bidder must be a/an
 - a) **Reputed bearing manufacturer:**
 - i. Manufacturer experience should be minimum of 5 yrs from the date of issue of the tender.
 - ii. Company Registration Certificate must be submitted.
 - iii. Supply of similar bearing amounting to a sum of ₹

4.0 lakh and above in last three financial years (i.e. FY 2021-22, 2022-23 and 2023-24).

or

b) Manufacturer's authorized Dealer:

- Manufacturer's authorization certificate must be submitted.
- The experience of their manufacturer of having successfully completed similar supply of last 03 (three) financial years (i.e. FY 2021-22, 2022-23 and 2023-24) should be at least amounting to a sum of Rs.4.0 lakh and above.

or

c) Reputed vendor or supplier: In case the bidder other than authorized dealer or manufacturer,

- The bidder must have experience of successfully executing the supply of such bearings. Experience of having successfully completed similar supply of works for last 03 (three) financial year (i.e. FY 2021-22, 2022-23 and 2023-24) should be at least amounting to a sum of Rs.4.0 lakh and above.

d) All bidders are required to submit the following documents along with the bid.

- Work completion certificate
or
- Inspection report if any
or
- Invoices as proof of payment against PO
or
- Signed and acknowledge copies of delivery challan.

In absence of the above requisite documents, the bidder may be considered as non-responsive.

(D) Bid submission

- a) The bid shall be completed in a single bid system. The bid shall be submitted in sealed envelope clearly superscribe with "Tender Notice no. 14 of 2025 "Supply of 02 nos of each **Ball & Roller Thrust** bearing for CW pump of NRPP, General Manager, NTPS, APGCL, Namrup, Dibrugarh – 786622".
- b) The bid shall include the following documents:
 - i. Photocopy of valid GST registration of the firm/dealer/manufacturer.
 - ii. Photocopy of PAN Card of the owner of the firm/dealer/manufacturer.
 - iii. Income Tax return of the previous three years (i.e., FY 2021-22, 2022-23 and 2023-24).
 - iv. EMD: The bidder must deposit the EMD (Earnest money deposit) of 2% of quoted price in the form of Bankers

Cheque/Demand draft duly pledge in favour of AGM (F&A), NTPS, Namrup. The bid without EMD or EMD of amount less than the specified value shall be rejected out write.

- v. Documents related to bidder's eligibility and experience shall be as mentioned in **SECTION 1** in clause **(C)**.
- vi. All pages of bid documents shall be stamped and signed by authorized signatory of the bidder.
- vii. Product brochures/ technical specifications of the proposed bearings.
- viii. The financial bid form (Annexure-A) dully filled providing the unit price and total price for each item including all applicable taxes, duties etc. Prices must be quoted in INR only.

(F) Amendment of Bid documents: The GM, NTPS, APGCL may, at its discretion, amend the bid document at any time prior to the deadline for bid submission. All amendments will be made through addenda.

(G) Scope of Work:

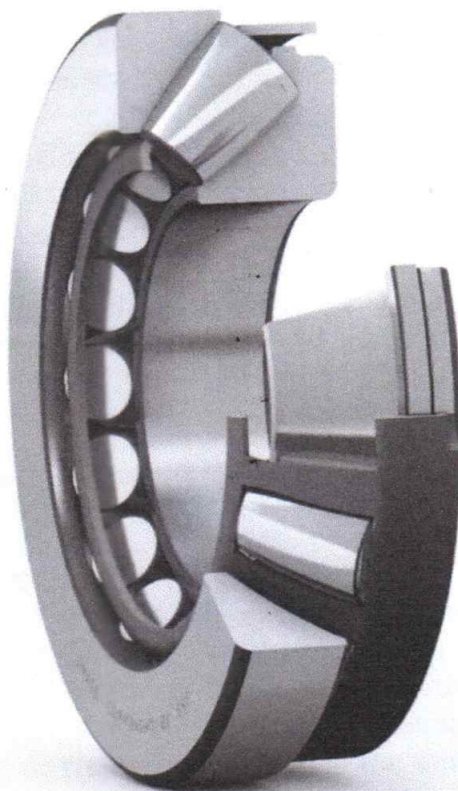

(H) Terms & Condition:

- a) **Price:** The Unit price(s) quoted by the bidder shall be firm without any variation in any way till completion of the supply in full. The basic price along with all applicable taxes shall be quoted in the finance bid form (Annex-A) of the submitted tender. Total GST shall also be quoted for every line item. Necessary P&F, Freight, Transit Insurance, Loading and Unloading charges shall be at the bidder's scope.
- b) **Bid/Price validity:** The bidder's Bid shall be valid for a period of 90(ninety) days from the date of opening of bid. However, in exceptional circumstances, NTPS, APGCL may request the bidder for an extension of the bid validity period.
- c) **Cost of Tender Paper (non-refundable):** A non- refundable bid document cost of Rs.336/- (Rupees Three hundred thirty-six) only in the shape of demand draft/bankers' cheque, drawn in favour of the Asstt. General Manager (F&A), NTPS, APGCL, Namrup.
- d) **Issue of Tender Paper:** At Technical Cell, O/o the General Manager, NTPS from 11.09.2025 to 22.09.2025 (up to 12.00 Hrs).
- e) **Performance Security Deposit:** The successful bidder shall furnish a Performance Security deposit equivalent to 10(ten)% of the total contract value in the form of a Bank Guarantee from a nationalized/scheduled bank of RBI, immediately within 10 (ten) days from the date of receipt of the LOI/Work Order duly pledged in favour of the Asstt. General Manager(F&A), NTPS, APGCL, Namrup. The Performance Security shall be valid for a period of 1(one) month beyond the warranty period.
- f) **Delivery Period:** The supply of all bearings must be completed within 45(forty-five) days from the date of acceptance of the LOI /Work Order by the successful bidder.
- g) **Payment Terms:** No advance payment is permissible.100% payment along with applicable taxes and duties shall be made after successful delivery of materials in full & good condition at NTPS site subject to satisfactory joint inspection report of the Central store officer with the user divisions.
- h) **Award of Contract:** The responsive bidder shall be issued whose financial bid is the lowest (L1), subject to satisfactory fulfillment of all terms and conditions. Bidder shall confirm acceptance of the LOI/Work order. In case the bidder does not respond within 5 days, it will be presumed that the bidder has accepted the work order.
- i) **Refund of EMD:** Earnest money deposited will be refunded to all except the successful bidder without any interest after awarding the work to the successful bidder. The EMD of the successful bidder shall be refunded without any interest after submission of Performance Security deposit.
- j) **Forfeiture of EMD:** EMD will be forfeited if the bidder withdraws or amends or deviates from the tender in any respect within the period of validity of the tender.
- k) **Owner's right to accept or reject a bid:** NTPS, APGCL, reserves the right to accept a bid other than the lowest and to accept or reject any bid in whole or part, or to

reject all bids with or without notice or reasons. Such decisions by NTPS, APGCL shall bear no liability whatsoever consequence upon such decisions on contractors.

- l) Warranty:** The supplied bearings shall be guaranteed for a period of 12 (twelve) months from the date of successful installation or 18 (eighteen) months from the date of supply whichever is earlier. Free replacement of the materials shall have to be done for any defect that may develop under normally used during the guarantee period. The free replacement must be done within a minimum period as determined and directed by NRPP, APGCL. Guarantee certificated should be furnished by the bidder along with the delivery of the materials.

- m) Liquidated Damages (LD):** In case of delay in supply of the material beyond the supply completion period, APGCL shall be entitled to: -

Recover an amount at the rate of 1 % of the total value of Contract Price/Purchase Order value per week or part thereof of delay, subjected to maximum of 10% (ten percent) of the Contract Price/Purchase Order value as Liquidated Damages. However, the payment of liquidated damage shall not in any way relieve the Contractor from any of its obligation to complete the supply or from any other obligation and liabilities of the Contractor under the Contract/as per Purchase order

- n) Force Majeure:** Normally, force majeure shall cover only act of God, fire, war, riots and act of Government etc. Any constraints other than those specified above will not constitute a force majeure condition. In view of other constraints beyond the control of the Contractor, primarily due to statutory compulsion, extension of delivery time may also be considered on merit of individual case. In case of a force majeure condition, the Contractor shall notify APGCL in writing such condition within 10 (ten) days from the beginning of such delay for consideration and acceptance.

- o) Arbitration Clause:** All disputes or differences whatever so arising between the parties out of or relating to the Order/Contract shall be settled by arbitration as per clause 33.00 of "General Conditions for Supply and Erection of APGCL, 2014". The document, "General Conditions for Supply and Erection of APGCL, 2014" is available at APGCL website.

- p) Rejection:** In the event, any of the materials supplied by the Contractor or work executed is found defective or otherwise not in conformity with the requirements of the contract/tender specifications, APGCL shall either reject the material/work or request the Contractor in writing to rectify the same. The Contractor, on receipt of such notification shall rectify or replace the defective material/rectify the defective work free of cost to APGCL. If the Contractor fails to do so, APGCL may at its option: -

- Replace or rectify such defective/non-conforming material/correct the defective work and recover the extra cost so involved plus 15% as overhead charge from the Contractor, or
- Terminate the order for default.

- q)** In case of any disputes or differences arising out of or relating to this order, the decision of the ZPC (Zonal Purchase Committee), O/o the GM, NTPS shall be final.

r) Others:

1. All pages of the submitted bid should be duly signed by the concerned bidder.
