No. ABP.81/2022/58 dated Dispur, the 18th January, 2023, if no eligible incumbent belonging to shortfall category (i.e. SC, ST-H & ST-P), is available, the number of posts that are required to meet the calculated shortfall shall be kept vacant and vacancy shall be carried forward and filled up in the next year i.e. the roster points earmarked for shortfall category (i.e. SC, ST-H & ST-P) shall be reserved for a period of 2 (Two) years w.e.f. the date of arising vacancy as decided by the DPC, APGCL. Further, if sufficient nos. of SC or ST-P or ST-H candidates, fit for promotion against reserved posts, are not available and if the posts cannot be allowed to remain vacant on grounds of maintaining efficiency in administration, the vacancy may be referred to Deptt. of Personnel, GoA for de-reservation, subject to the condition that no eligible candidate belonging to the category for which the post is reserved, is available within the zone of consideration placed before the DPC, APGCL for 2 consecutive years. In other words, the proposal for de-reservation may be moved in the third year.</p>
