In case bidder has claims above 50% of his total asset value, such bidder shall be treated as non-responsive. Bidders shall submit details of all the litigation, arbitration or other claims, whether pending or threatened in the technical bid. • The bidder must be a manufacturer of Silent Diesel Generating Sets of capacity 500 KVA or above or the bidder must be manufacturer's Authorized Firm. • The OEM's Manufacturing factory should be located in Assam for ease of carrying out factory inspection and a Service Unit in the State of Assam for fast & timely availability of the Service for repairing and maintenance of the supplied DG sets to APGCL. • For other Eligibility Criteria and Terms & Conditions, etc., bidders may refer to the bid document.
