Name of the work	Design, supply, installation, testing and commissioning of 33 KV outdoor Switchyard at 2X50 MW Karbi Langpi Hydro Electric Project (KLHEP), APGCL, West Karbi Anglong, Lengery, Assam for power evacuation from 13.5 MW Myntriang Small Hydro Electric Project (MSHEP) to KLHEP power house and project area through the newly constructed 33 KV Switchyard.
Bidder Eligibility Criteria	<ul style="list-style-type: none">• The Bidder should not have been blacklisted by any State Government, Central Government, State PSU, Central PSU, Private Company, etc.• The Bidder must have average annual Turnover of at least Rs. 3.00 crore (Rupees three crore only) during last 03 (three) Financial Year.• Net Worth of bidder must be positive in FY 2021-22.• The bidder should not have any pending or threatened litigation, arbitration or other claims amounting to more than 50% of bidder's total asset value. In case bidder has claims above 50% of his total asset value, such bidder shall be treated as non-responsive. Bidders shall submit details of all the litigation, arbitration or other claims, whether pending or threatened in the technical bid.• The Bidder must possess valid Electrical Contractor License and Electrical Supervisor License (HT 33 KV or above) issued by Govt. of Assam.• The bidder must have work experience of constructing 33 KV or above outdoor Switchyard for Power Utility Companies/State Electricity Boards in India.• For other Eligibility Criteria and Terms & Conditions, etc., bidders may refer to the bid document.
