Bidder Eligibility Criteria	<ul style="list-style-type: none">• The Bidder should not have been blacklisted by any State Government, Central Government, State PSU, Central PSU, Private Company, etc.• The Bidder must have average annual Turnover of at least Rs.2.78 Crores Only (Rupees Two Crore Seventy-Eight Lakh Only) during the 03 (three) Financial Year, FY 2020-21, 2021-22 & 2022-23.• The Bidder must be a manufacturer (OEM) of Diverter Damper of Gas Turbine Units or manufacturer's authorized vendor.• The bidder must have past experience of successfully executing at least 01 (one) no. work of supply, installation and commissioning of Diverter Damper for Gas Turbine of Capacity of 60 MW or above. In case of Authorized Vendor, the past experience of their OEM can also be considered for supplying Diverter Damper for Gas Turbine of 60 MW or above. However, the Authorized Vendor should have experience in Installing and commissioning such Diverter Damper. Authorization Letter from the OEM must be submitted in the technical bid.
